OUR MISSION

The WRC's mission and priorities are twofold: 1) to help Alberta workers understand their rights in the workplace, and 2) to assist clients in navigating claims, complaints and appeals if those rights are not being upheld.

OUR WORK

The WRC is a charitable organization that provides support in three main areas:

- 1) Casework - our caseworkers assist clients in navigating claims, complaints and appeals.
- 2) Public Legal Education - our public legal educator hosts workshops on a variety of employment-related topics.
- 3) Workplace Sexual Harassment Advisory Program - provides education on preventing sexual harassment, and supported legal referrals.



MESSAGE FROM OUR INTERIM BOARD CHAIR

2020 was a challenging year for all individuals, but I am excited to be able to report on another year of successes for the WRC.

There were many challenges that the WRC staff faced in being able to continue to offer workshop and casework support in a fully virtual setting. The agency quickly transformed houses into home offices, and adapted materials and forms to be accessible online.

The agency also embarked on a new program to offer support and education to individuals who have experienced sexual harassment in the workplace. This program is generously funded through the Federal Department of Justice and has a five-year funding guarantee. This program complements the WRC's existing core programs.

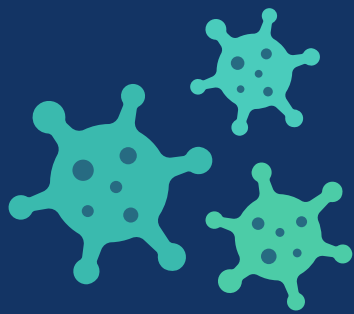

Teodora joined the WRC in April 2020. Teodora brought with her her extensive knowledge of government benefits due to her prior experience working for Alberta Works.



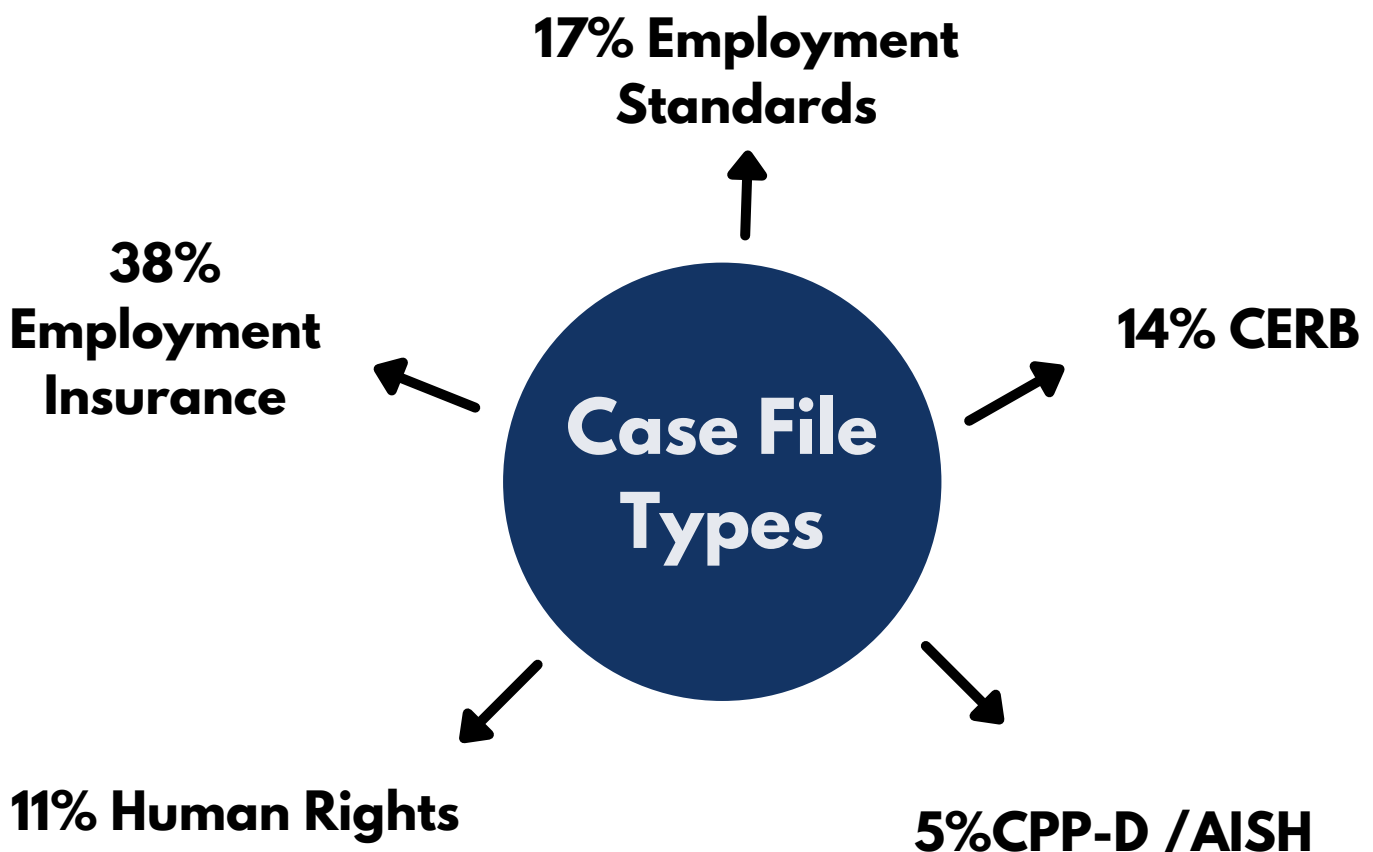

EDUCATIONAL PHILOSOPHY

The PLE Program is based on the philosophy that knowledge leads to empowerment. The more an individual knows about their rights in the workplace, the better they will be able to identify violations of these rights.

The PLE offers workshops on a variety of topics including: Employment Insurance, Employment Standards, WCB, Occupational Health and Safety, Changes to Legislation, and others.

The WRC believes that knowledge leads to the power to self-advocate, and understand individual ability to do so.

SEXUAL HARASSMENT ADVISORY PROGRAM

BACKGROUND

In 2019, the WRC applied for a grant from the Federal Department of Justice to offer supports and resources centered on addressing sexual harassment in the workplace.

The WRC was awarded a five year funding guarantee to offer this program in early 2020.

Program Highlights:



Formed the Sexual Harassment Partnership group to offer collaboration and training opportunities.



Created resources and content that can be delivered in person or virtually.



WRC Success Stories

“ I helped a client that was having issues with an AI SH appeal. He had immigrated to Canada a few years prior and was confined to wheelchair due to a childhood illness. He and his wife had a very young family he needed to support financially, but is unable to work due to illness.

I contacted his medical team, past and present, assisting him in tracking down medical documents for proof of injury. We were successful in his AI SH appeal. He received a total of \$643,140.00 to be dispersed to him monthly over the next 33.5 years

WRC Success Stories

“ This client contacted the WRC for assistance with a CPP-D application. The client had attempted to apply on his own the year prior but was unsuccessful. WRC reviewed the client's denial letters and determined that he had been denied for formalities which the client had unknowingly overlooked in his application. WRC assisted the client with a second application, making sure all important information was provided to Service Canada, which was ultimately approved in a matter of two or three months (his benefit rate was approximately \$1200 per month with four years of eligibility - or \$57,600 in total gross benefits). The client has since expressed a sincere gratitude for the WRC's assistance, as he feared he would never receive the financial assistance from CPP-D that he required.

Her work career, here in Calgary, has included: Counsellor at Calgary Communities Against Sexual Abuse; The Calgary Women's Emergency Shelter; and, The University of Calgary's Counselling Centre where she completed 1600 hours of supervised counsellor training. Also, during her counselling career, Terri has been involved in counsellor/volunteer training and public education/outreach.

Karen Craik is a Registered Nurse and has had the pleasure of representing her members as Secretary Treasurer of United Nurses of Alberta since 1996. Karen was the founding Chair of the Calgary Workers' Resource Centre and served on the Board for many years. She has also served on the Board of Ovarian Cancer Canada and was a founding co-chair of the Ovarian Cancer Walk of Hope in Calgary. Rejoining the Board of the Workers' Resource Centre is like coming home. It is so important to support and educate workers' on their rights of Employment.

Alex is President of the Calgary and District Labour Council. In that role, he represents the interests of affiliated unions before the City of Calgary, the school boards and the community.
